ELIGIBILITY - NORTH AMERICAN RESIDENT RACERS ONLY

2009 SEA-DOO X-TEAM BOUNTY Eligibility Rules:

READ ALL APPLICABLE RULES BELOW TO QUALIFY

1. To be eligible for the Sea-Doo Bounty contingency, racer must compete on an IJSBA / APBA eligible Sea-Doo watercraft in the specified class(es) described in the rules and contingency tables within North America. Race events offering the Sea-Doo Bounty are all those in North America sanctioned by either the IJSBA or the APBA.
2. Contingency prizes will be paid to racers competing in the designated classes aboard eligible, 4-TEC powered Sea-Doo watercraft.
3. ONLY racers residing in North America (US & Canada) qualify for contingency.
4. ONLY racers competing on 4-TEC powered vehicles qualify for contingency.
5. Contingency prizes will be paid for overall closed-course racing only. Slalom does not apply. In IJSBA World Finals contingency, only Overall Titles will be paid (which in some cases may include slalom).
6. Racer must list **Sea-Doo** as the brand of watercraft raced and "**SEA-DOO X TEAM**" as a sponsor on entry.
7. The SEA-DOO BOUNTY logo decal must **be clearly visible** and legible on the watercraft forward of the handlebars. Sea-Doo logo decals must be clearly visible on both sides of the watercraft - minimum of two (2") inch tall lettering. Sea-Doo Bounty logo decal to be supplied by promoter.
8. Racer is eligible for as many contingency payments as earned during an event. Racer MUST compete against a **MINIMUM OF FIVE** (5) finalists in the class to qualify for contingency.
9. To qualify for contingency payment, BRP MUST receive a completed Sea-Doo X-TEAM Bounty Contingency Redemption Form from eligible racer within (10) ten days of race event.
10. Racers will receive one single compiled contingency payment for designated race events taking place between March 15, 2009 – June 21, 2009, and another single compiled contingency payment for designated race events taking place between June 22, 2009 – September 6, 2009. Racers will receive one single payment for contingencies earned at the IJSBA World Finals in October, 2009.
11. Contingency payments will be issued to racers from BRP only after the IJSBA /APBA and BRP have verified official results.
